Excess: No excess

Co-payments: Every time you go to hospital you will have to pay:

- \$55 per day for a shared room for overnight admissions - up to \$275 per hospital stay
- \$55 per day for a private room for overnight admissions - up to \$275 per hospital stay

The following waiting periods for hospital admissions apply to new or upgrading members**Waiting periods:**

- 2 months for palliative care, rehabilitation and hospital psychiatric treatments, even if pre-existing
- 12 months for other pre-existing conditions
- 12 months for pregnancy and birth (obstetrics)
- 2 months for all other treatments
