Waiting periods:

- 2 months for palliative care, rehabilitation and hospital psychiatric treatments, even if pre-existing
- 12 months for other pre-existing conditions
- 2 months for all other treatments

Ambulance cover

In SA this policy provides:

Emergency: Unlimited with no waiting period.

Please note: This cover doesn't include non-emergency ambulance transportation.
