- 12 months for other pre-existing conditions
- 2 months for all other treatments

Additional Benefits include: Hospital Substitution Programs, Travel and Accommodation, Health Support Programs and Preventative Health Services, waiting periods may apply. Ambulance cover

In SA this policy provides:

Emergency: Unlimited with no waiting period.

Call-out fees: Will be paid for each attendance, including emergency treatment without transport to hospital.

Please note: This cover doesn't include non-emergency ambulance transportation.
