Breathing appliances (12 month waiting period), fixed benefits, benefit replacement periods apply and \$180 limit per member every 3 years. Blood glucose monitors share a per member limit of \$240 every 3 years with Blood pressure monitors (24 month waiting period). Counselling and Pharmacogenetic Testing share an annual limit of \$400 with Psychology.
