- 12 months for other pre-existing conditions
- 12 months for pregnancy and birth (obstetrics)
- 2 months for all other treatments

Other features of this general treatment cover: Health appliances and external prostheses (2 month waiting period) fixed benefits, benefit replacements apply - \$500 annual limit. Breathing appliances (12 month waiting period), fixed benefits, benefit replacement periods apply and \$180 limit per member every 3 years. Blood glucose monitors share a per member limit of \$240 every 3 years with Blood pressure monitors (24 month waiting period). Counselling and Pharmacogenetic Testing share an annual limit of \$400 with Psychology.
